As part of our commitment to ensuring stakeholder input and engagement we have provided numerous community engagement opportunities during the 2020-2021 school year to gather feedback to inform and direct the development of the Expanded Learning Opportunities Grant Plan (ELOGP) and the Local Control Accountability Plan (LCAP). The feedback received from the various stakeholder groups; parents/guardians, school staff, general and special education staff and families, the ELAC committee regarding the ELOGP and the LCAP was used in the development of this ESSER III expenditure plan. Zoom meetings with parents/guardians, staff meetings, surveys, student achievement data analysis and outreach via phone/email were used to solicit meaningful feedback from the community to identify students, as well as their families in need of academic and/or social/emotional supports. The ESSER III plan will be posted on the Alma Fuerte website for additional visibility and

input as well as referenced at the recurring Zoom parent/guardian meeting for discussion. Furthermore, at a regularly scheduled Governing Board meeting to be held in October, Alma Fuerte will include the ESSER III plan on the agenda for approval and the opportunity for public comment.

Feedback from the community engagement strategies described above was incorporated into the development of the specific strategies for addressing the loss of instructional time and providing supplemental instruction and support to identified students. Additional feedback from the ELOGP and LCAP remained consistent with current feedback, including a commitment to in-person learning, smaller class sizes and personalized instruction, small group support for math and reading, maintain strong counseling support programs and weekly newsletter, student interventions, enrichment opportunities and high quality summer school opportunities. The services and opportunities for students as described in the ESSER III plan incorporate this feedback and continues to build on the ELOGP and LCAP goals of supporting safe and continuous in-person learning and addressing the academic, social, emotional, and mental health needs of all students.

Feedback from the community through our outreach strategies was incorporated into the development of strategies to mitigate the impact of loss of instructional time, expand supplemental instruction and to support identified students in need. The identified needs from stakeholder engagement from the ELOGP AND LCAP remained consistent and focused on a commitment to:

- provide in-person learning
- including after school tutoring and summer school opportunities
- ensuring smaller adult to student ratios
- more personalized instruction
- expanded SEL and counselling services/support
- a robust RTI and MTSS
- family/community outreach and support

The services, supports and opportunities as described in the ESSER III plan incorporate this feedback and emphasizes the goals of supporting safe and continuous in-person learning while addressing the academic, social, emotional and mental health needs of all students and their families as contained in the ELOGP and LCAP.

ESSER III Expenditure Plan Instructions

Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before October 29, 2021 and must be submitted for review and approval within five days of adoption. A school district must submit its ESSER III Expenditure Plan to its COE for review and approval; a COE must submit its plan to the California Department of Education for review and approval. A charter school must submit its plan to its chartering authority for review and to the COE of the county in which the charter school operates for review and approval.

In addition, consistent with the requirements of the ARP, Volume 86, *Federal Register*, page 21201, April 22, 2021, the ESSER III Expenditure Plan must be:

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
 - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.

 - **Tier 4 – Demonstrates a Rationale:** practices that have a well-defined logic model or theory of action, are supported by research, and have some effort underway by a State Educational Agency, LEA, or outside research organization to determine their effectiveness.

- Developing strategies and implementing public health protocols including, to the greatest extent practicable, policies in line with guidance from the Centers for Disease Control and Prevention (CDC) for the reopening and operation of school facilities to effectively maintain the health and safety of students, educators, and other staff;
- Other activities that are necessary to maintain the operation of and continuity of services in LEAs and continuing to employ existing staff of the LEA.
